1. I, Steven-Alan: Magritz, in correct public capacity as beneficiary to the Original Jurisdiction, being of majority in age, competent to testify, a self realized entity, a free man on the land, my yes be yes, my no be no, do state that the truths and facts herein are of first hand personal knowledge, true, correct, complete, certain, not misleading, so help me YHVH.
2. Affiant has not seen or been presented with any material fact that anyone, other than Affiant, is Claimant to the 62.25 acres of ground (land) with homestead thereon in Fredonia Township, Ozaukee County, Wisconsin State, from which Affiant and his wife were forcibly removed at gunpoint on October 24, 2001, by Maurice A. Straub and dozens of his heavily armed men, some with "machine guns", ~~and~~ ^{and} nine of whom wore full military camo and concealed their identities with black masks.
3. On April 30, 2001, Affiant owed no taxes on his aforesaid 6.25 acres of land and homestead. [Wisconsin Constitution Article I, Sec.14; HJR-192, ~~ISS~~ 10-104; Wis. Stats. 403.603-604].

4. On May 31, 2001, Affiant's Claim (Answer to Alleged Tax Foreclosure Summons and Complaint, Ozaukee County Case #01-CV-58-B3) with approximately 135 pages of documents in support was received by Jeffrey S. Schmidt, Clerk of Court, via U.S. mail, registered return receipt (recorded in the office of the Register of Deeds, document #687553).
5. The aforesaid documents received by Schmidt were time and date stamped, but instead of placing them in the case file, Schmidt transferred them to Dennis E. Kenealy, Ozaukee County Corporation Counsel and Affiant's opponent's attorney, who concealed them.
6. Schmidt thereupon did NOT record the receipt of Affiant's documents on the docket sheet.
7. Affiant offers as substantiation of the foregoing with regard to Schmidt the following:
 - 1) Admissions by Schmidt and ^{affidavit} ~~affiants~~ by witnesses recorded in the office of the Register of Deeds, document number 698440 and 698699;
 - 2) Certified copies of missing documents (file stamped received May 31, 2001, 9:41 A.M.) that mysteriously appeared in the case file AFTER December 12, 2001, when Schmidt, confronted with their absence, made a hasty phone call to Dennis E. Kenealy;
 - 3) Certified copy of the docket sheet evidencing that the documents received on May 31, 2001 were NOT recorded as having been received.

8. On May 31, 2001, the Affiant's Claim (Answer) was received by Karen L. Makoutz, County Treasurer, via U.S. mail , certified return receipt (recorded in Deeds, doc. #687553).
9. Makoutz subsequently admitted transferring the Answer to Dennis E. Kenealy, who concealed the Answer (see Makoutz admissions, Deeds #698440).
10. On August 9, 2001, Judge Joseph D. McCormack signed a Default Judgment against Affiant that Kenealy had drafted that stated that NO ANSWER WAS RECEIVED BY KAREN L. MAKOUTZ.
11. Dennis E. Kenealy subsequently admitted concealing the aforesaid public documents as well as advising the Register of Deeds NOT to file Affiant's correction statement of Real Estate Transfer Tax Return (Form PE-500) thereby causing falsification of public records by denying Affiant the ability and duty to correct the public record (Deeds, doc.#708567). See also the May 30, 2002 Preliminary Hearing Transcript, Dane County Case #02-CF-1170, pages 78-80.
12. On September 24, 2001, Ozaukee County Sheriff's Deputy G. L. Speth served a 155 page Claim with supporting documents on the entire Ozaukee County Board of Supervisors by service on Harold Dobberpuhl, County Clerk. (Deeds, doc.numbers 688709 and 692784).
13. The County Board never heard Affiant's aforesaid Claim in spite of the \$600,000 to \$700,000 value involved.
14. Upon reason and belief, Harold Dobberpuhl transferred Affiant's Claim to Dennis E. Kenealy.
15. Upon reason and belief, Dennis E. Kenealy concealed Affiant's Claim from the County Board of Supervisors.
16. In April, 2002, Dennis E. Kenealy, without any facts in evidence appearing in either the case file or on the docket sheet that Kenealy had standing, filed for an injunction against Affiant prohibiting Affiant from petitioning for Redress of Grievance and prohibiting Affiant from filing documents with the Register of Deed where Affiant had previously documented Kenealy's acts and actions against Affiant.
