Dear Marylou Mueller,

Please be advised a private courier *visited* the Office of the Clerk of Court, Ozaukee County, on January 5, 2012. The *visitor* obtained a certified copy of my letter to you dated December 9, 2011 titled **NOTICE OF REFUSAL FOR FRAUD**. This letter was properly time and date stamped as received by the court on December 12, 2011. This letter stated that "enclosed herewith" was a copy of a letter titled **Re: Ongoing Criminal Activity by Public Officers**, which letter was addressed to public officers, your name being the eighth name on the list. Also referenced as enclosed was my affidavit dated December 9, 2011 titled **12/09/2011 REPORT OF CRIMINAL ACTIVITY BY VICTIM/WITNESS**.

The *visitor* obtained certified copies from the court of the aforesaid letter to Public Officers and the Affidavit of Criminal Report, **both** of which were clearly marked with the case number, "2011CF000236". However, *neither the letter nor the affidavit were time and date stamped as received by the court*, although they obviously were received since they were in the same envelope as the **NOTICE OF REFUSAL FOR FRAUD** and were in the case file.

The *visitor* did not find any Respondent affidavit rebutting my affidavit dated December 9, 2011 titled **12/09/2011 REPORT OF CRIMINAL ACTIVITY BY VICTIM/WITNESS**.

Further, the internet website CCAP for the Ozaukee County Circuit Court indicates on that "Other Papers" were received on December 12, 2011, but does not indicate receipt of my aforesaid letter and affidavit.

Please explain to me why **neither** the aforesaid letter **nor** the affidavit were time and date stamped as received by the court, why they are not identified on CCAP, and whether or not you are going to correct the record. Please time and date stamp the enclosed copy of this letter and return it along with your explanation in the stamped, addressed envelope.
