**Re: Criminal Activity of Michael B. Brennan and Michael Y. Scudder, dba  
Circuit Court Judges, Seventh Circuit Case No. 19-1518**

**Judges are NOT above the law**

1. On March 18, 2019, district court judge Lynn S. Adelman of the ED of Wis. denied a Fed. R. Civ. P. 60(b)(1) motion in Case No. 18-CV-00455, thus admitting he had *knowingly and intentionally* issued the November 28, 2018 "Decision and Order" based upon his false, fabricated, concocted, manufactured, phony, conjured up, non-existent "state-law", thereby committing crimes against The United States of America. See page 7, paragraph 25, of affiant's "Informant's Report of Felonies Cognizable by a Court of the United States, Reported Pursuant to 18 U.S.C. § 4", revised 12-01-2019, *incorporated herein by reference*.
2. Adelman had previously dismissed petitioner Steven Alan Magritz's 28 U.S.C. § 2254 petition for writ of habeas corpus on "procedural default" grounds, claiming petitioner had failed to follow Adelman's false, fabricated, concocted, manufactured, phony, conjured up, non-existent "state-law".
3. Adelman never denied the "structural defects" of bias and denial of assistance of counsel, as well as other egregious denials of due process by persecuting state court judge Williams whom Magritz had sued in federal court and against whom Magritz had filed a criminal complaint with the State Attorney General, Governor, et al., and had featured as a corrupt judge on [www.OzaukeeMob.org](http://www.OzaukeeMob.org), about which Williams had expressed her disdain at sentencing.
4. On March 21, 2019, Magritz filed a notice of appeal and a "Request to Circuit Justice Brett Kavanaugh for a Certificate of Appealability" with the Seventh Circuit.
5. On May 7, 2019, after discovering the Circuit Court was "dragging its feet", Magritz filed a Notice and a "Replacement Request" with the Seventh Circuit. See Attachment # 1 of 4, document 1), incorporated herein by reference.

6. On September 30, 2019, after communicating with the DOJ and after six (6) months stonewalling by the Seventh Circuit, Magritz filed an "Informant's Report of Felonies ..." with the DOJ, the local FBI-SAC, and Diane Pamela Wood, Chief Judge, which was *improperly and wrongfully* filed in the habeas appeal on October 4, 2019, dkt. 6, presumably by Wood.

7. On October 15, 2019, after almost seven months of stonewalling by the Seventh Circuit and mere days after the criminal complaint was improperly filed in civil case # 19-1518, judges Michael B. Brennan and Michael Y. Scudder issued a false and deceitful "Order" denying the request for a certificate of appealability. See Attachment # 1 of 4, document 2), incorporated herein by reference.

8. The undersigned charges Brennan and Scudder with conspiracy, obstruction of justice, covering up malversation by federal judge Lynn S. Adelman and state judge Sandy A. Williams, including but not limited to retaliation against a victim and witness of crime, and knowingly filing a false document with a federal court, all of which are criminal acts against The United States of America and the United States.
